Their education includes Clinical Supervision Training, a Master of Science in Mental Health Counseling and Chemical Dependency from the University of Wisconsin - Stout, studies at the University of Limerick, and an undergraduate degree from the University of Wisconsin-Stevens Point in Psychology and Sociology.

**Barry Taylor**, DMD, is the Executive Director of the Oregon Dental Association (ODA) and is a volunteer Clinical Assistant Professor at the Oregon Health & Science University School of Dentistry. Before attending the OHSU School of Dentistry, he worked as a research assistant for two years in Neuropsychopharmacology at the US Veteran's Hospital in Portland, Oregon.
